Chapter 2: Business Licenses (Appendix "A")

Business licenses are considered pending until final approval by the Bryce Canyon City Council. Licenses are issued on a calendar year basis January – December.

Late Payment & Violations of Business License

A \$10 penalty fee shall be charged for any business license which has not been paid by February 1st;

Liquor License:

Class A: Retail* Sell in original containers to consume off premises - Holders of a Class A license shall maintain records which shall disclose the gross sale of beer during each and every year.

Chapter 3: Recreational

Park/Wellness Center

Reservations are required for any use of City’s facilities; inquire at the Bryce Canyon City Office.

Two keys will be issued to adults under the family plans and one key per single plan. A \$10.00 fee will be charged for key replacement.

Rental Fees: Fees and security deposit may be refunded in full if the reservation is canceled within 48 hours of reservation date or due to inclement weather the event is canceled; half (½) of the fee will be refunded for cancelations made on the appointed day. **Bryce Canyon City reserves the right to refuse rental of any person or entity for any reason with or without cause.**

Personal Trainers:

\$10.00 fee per person

Trainer and trainees must pay the weight room fee

Gym Rental

- Must meet with City Council for approval
- Health Classes 1-5 persons: \$25.00/Month, 6+ persons, \$50.00/month (no long term commitments, school functions receive priority for gym usage)
- Must pay the weight room fees
- Subject to scheduling
- No refunds will be given. Pricing subject to change without notice.
- Non Street Shoes are required for both the Gym and Weight Rooms.
- Damage Fees may be assessed

No charge for Town, County, Trainings, Civic Group meetings ~ however, all rules shall be adhered to; as well as clean-up

Chapter 4: Payment Options, Returned Checks and Returned Electronic Fund Transfer Fees

The City will only accept Cash, Credit Card, Personal Check, Cashier's Check, Money Orders for payment for business license dues. For gym/weight room Wellness Center fees or all other fees the City will only accept Credit or Debit Cards as a method of payment.


These fees include/not limited to non-sufficient funds or electronic fund transfers (EFT's) stopped payment checks or canceled accounts where funds were not available.
